### **2019-2020 Federal TEACH Grant Application**

**IMPORTANT:** Federal TEACH Grants will be awarded to eligible students for the 2019-2020 academic year. Eligibility and award is based on term enrollment. Students will be reviewed every term to ensure GPA and program eligibility. This form must be received in the Financial Planning office at least 30 days prior to your last date of enrollment during the 2019-2020 academic year.

**DIRECTIONS:** Complete this form to be considered for the federal Teacher Education Assistance for College and Higher Education (TEACH) Grant program. The TEACH Grant provides **up to \$4,000** per year (subject to funding approval by the U.S. Department of Education) (\$16,000 total for 4-year undergraduate programs and \$8,000 total for graduate programs) in grants to students who commit to:

1. Teach full-time
2. Teach in high-need subject areas
3. Teach for at least four out of the first eight years after completing the teaching degree
4. Teach at schools that serve students from low-income families.
5. Be enrolled in one of the following TEACH Grant approved programs at Converse:
  - a. Undergraduate: Comprehensive Special Education, Special Education – Learning Disabilities, Special Education- Intellectual Disabilities, Special Education – Deaf & Hard of Hearing, Math – Minor in Secondary Education, Biology or Chemistry – Minor in Secondary Education, Art Education, Music Education
  - b. Graduate: Special Education – Learning Disabilities, Special Education – Intellectual Disabilities, Middle Level Science, Middle Level Math, Secondary Program – Mathematics

**NOTE:** Failure to complete the service requirement and commitment for the TEACH Grant will result in the grant being converted to a Federal Direct Unsubsidized loan with interest calculated from the time of the grant disbursement.
